## INVITATION TO BID FOR THE CONSTRUCTION/REPAIR OF CDC (CHILD DEVELOPMENT CENTER), BRGY. SAN RAFAEL, MIAGAO, ILOILO

1. The Municipality of Miagao through the Budget for the Contract Approved by the Sanggunian, Trust Fund – DSWD, Budget Year 2019 intends to apply the sum of P 263,340.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Materials and Supplies for the Construction/Repair of CDC (Child Development Center), Brgy. San Rafael, Miagao, Iloilo. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Miagao now invites bids for the following:

Delivery of the Goods is required fifteen (15) calendar days after receipt of Notice to Proceed. Bidders should have completed within twelve (12) months, a contract similar to the Project from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws of regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5193 and subject to Commonwealth Act 138.
