

RESOLUTION NO. 2023 - 01

A RESOLUTION APPROVING THE PROPOSED AMENDMENTS IN THE BY-LAWS OF ILOILO PROVINCE KALIPI INC.

WHEREAS, the members of the Iloilo Province KALIPI Executive Council unanimously moved for the endorsement of the proposed amendments in the By-Laws to the Provincial Assembly on December 28, 2022 at Amita Cora Grill and Seafood Restaurant, ;

WHEREAS, no election at the city, municipality, or provincial level shall be held, until Calendar Year 2025 unless the Local Government Unit has not yet previously organized its KALIPI;

WHEREAS, for a city, municipal, or province that has already held their KALIPI elections in 2022, the new set of officers shall be considered;

WHEREAS, the incumbent officers shall serve until the year 2025. A KALIPI President or officer who has not yet reached 60 years old by the time of the election and turned 60 while serving her term shall be allowed to serve and complete her term at all levels (barangay, city, municipality, provincial, regional, and national);

WHEREAS, in the absence of a President, the Vice President shall act as the Officer-in-Charge (OIC) of the organization. In the absence of the Secretary, Treasurer, and other main posts, their respective assistant shall take responsibility

WHEREAS, in reference to the schedule election of officers at the national level which shall be held within October or November; the election of officers at the provincial level shall be held in July;

WHEREAS, individual membership shall be TWENTY PESOS (Php20.00) until the new rate is approved by the KALIPI-Nasyonal;

WHEREAS, in reference with the KALIPI registration at the national level which is Five Hundred Pesos (Php500) per chapter, the registration at the provincial level is at TWO THOUSAND PESOS (Php2,000.00) per city/municipal chapter regardless of the number of individual members;

WHEREAS, every individual member shall be given an Identification (ID) card upon finalization of appropriate signatory by the KALIPI-Nasyonal;

WHEREAS, validity of ID is minimum of three (3) years and maximum of nine (9) years depending on the term of the President;

WHEREAS, printing of ID shall be the responsibility of the Provincial Social Welfare and Development Office (PSWDO) until Iloilo Province KALIPI Inc. is financially capable of printing;

WHEREAS, KALIPI shall conduct various activities but shall not be limited only to advocacy activities. It shall also include activities or implement programs or projects that will further enhance the capacity and capability of KALIPI members;

WHEREAS, due to limited resources, the city and municipal chapters, in coordination and partnership with their City or Municipal Social Welfare and Development Officers, are requested to allocate budget for the conduct of Training on the Enhanced Modular Packages for Women;

WHEREAS, the official logo of KALIPI is the one bearing bamboos and female symbols in purple shade;

WHEREAS, pink is the official color of KALIPI;

NOW THEREFORE, on motion of Joffeylyn Semolava, President, KALIPI Janiuay and was duly seconded by Judy Pagaduan, President, KALIPI Lambunao.

BE IT RESOLVED AS IT IS HEREBY RESOLVED, the Provincial Assembly approves the amendment of the KALIP By-Laws in Iloilo Province .
