## **ORDINANCE NO. 2022-02**

AN ORDINANCE GRANTING FRANCHISE TO OPERATE TRICYCLE FOR HIRE WITHIN A SPECIFIED ZONE OF THE MUNICIPALITY TO A QUALIFIED INDIVIDUAL OF MIAGAO, ILOILO

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Miagao, Province of Iloilo, in session duly assembled, that:

**SECTION 1.** LEGAL BASES. Section 447 (a)(3)(vi) of Republic Act No. 7160. otherwise known as the Local Government Code of 1991 and Municipal Ordinance No. 2010-02 otherwise known as the "Revised ordinance prescribing the rules and regulations in the issuance of franchise to operate tricycles for hire in the Municipality of Miagao; Province of *Iloilo and for such other purpose*".

SECTION 3. TERMS AND CONDITIONS. The operation of the tricycle unit covered by the franchise is subject to terms and conditions provided for under the applicable provisions of Municipal Ordinance No. 2012-02, otherwise known as the "Revised ordinance prescribing the rules and regulations in the issuance of franchise to operate tricycles for hire in the Municipality of Miagao, Province of Iloilo and for such other purpose", as amended.

SECTION 4. MUNICIPAL TRICYCLE OPERATOR'S PERMIT. The Grantee shall be issued a Municipal Tricycle Operator's Permit (MTOP) signed by the Chairman of the Municipal Tricycle Franchising Board and the Municipal Mayor which shall be prominently displayed inside the sidecar of the tricycle unit at all times.

**SECTION** 5. WITHDRAWAL, CANCELLATION, REVOCATION OR SUSPENSION OF FRANCHISE. In case of violation by the Grantee of the terms and conditions and/or requirements provided herein and pertinent laws, ordinances, rules and regulations now existing and those that may hereinafter be promulgated, the Municipality of Miagao, through the Sangguniang Bayan, has the right to withdraw, cancel, revoke or suspend the franchise.

SECTION 6. REPEALING CLAUSE. All ordinances, rules and regulations or parts thereof in conflict or inconsistent herewith are hereby repealed or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE. In the event that any provision of this Ordinance is declared illegal, the validity of other provisions shall not be affected by such declarations which shall continue to be in full force and effect.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.
